

## **AFFIDAVIT**

- That school is not paying any charges towards using name, mo o, logo or any other non-academic ac vi es to any other ins tu on, organiza on or body
- That the school will not open classes under CBSE pa ern par cularly class VI to XII and will not use CBSE name in any manner without obtaining affilia on.
- 7. That the Principal and Correspondent/Manager of the school have individually gone through the provisions contained in the affilia on & examina on byelaws and the circulars issued by the Board from me to me. The school undertakes to abide by the provisions contained in the affilia on & examina on byelaws direc ons issued from me to me and the law of the land.
- That the school will ensure compliance of all statutory requirements like EPF. ESI and Labour Laws etc. with respect to the school and staff of the school
- That the school will ensure that the Building Safety, Fire Safety, Water Safety. Health and Hygiene cer ficates are being issued or renewed by the concerned municipal or state authori es from me to me as per the prescribed
- 10. That the school will ensure that all required infrastructure is available with the school before star ng classes. (present school started in 1991 i.e. 34 years old)
- 11. That the school will ensure that sufficient number of qualified teachers as per the provisions contained in affilia on bye-laws are available with the school before star ng classes
- 12. That the school will follow the provisions related to fee contained in affilia on bye laws and will disclose the details of the fee to the students/parents every year before start of session without resor ng to any hidden charges in the heads of the fee.
- 13. That the school will not coerce any student/parent to buy books/sta onary/uniform from any par cular shop
- 14. That the school shall strive to make efforts for conserva on of environment
- 15. That the school will ensure that the school fulfils all essen al requirement before applying for affilia on and will fulfil all other condi ons post affilia on and comply with all the general rules as given in the affilia on byelaws or no fied from me to me.
- 16. That the school will not start CBSE pa ern classes without submi ng a commencement cer ficate to the effect that the school has complied with all the condi ons imposed by CBSE and the post-affilia on condi ons contained in affilia on byelaws along with general rules.
