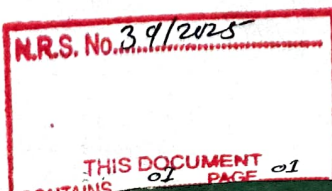
Grievance/Complaint Redressal Committee

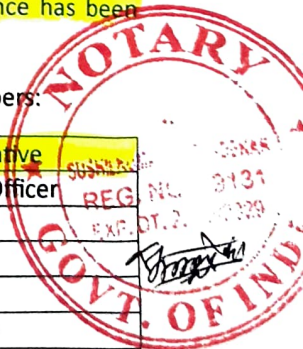
- Upholding the dignity of the school by ensuring a healthy atmosphere in the school through promoting cordial student-teacher relationship.

- The Grievance Committee will act upon the cases and will assure that the grievance has been properly solved in a stipulated time limit provided by the cell.

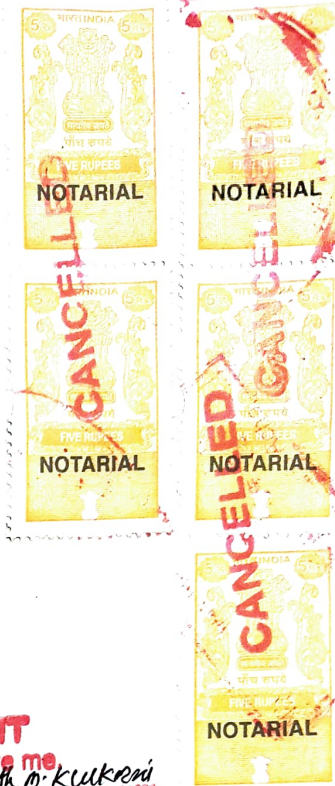
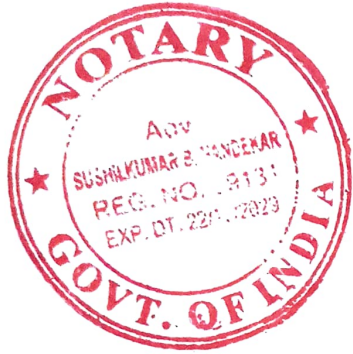
